1. Compliant received from investor Mr. Chandresh Sharma for non-receipt of refund order in respect of Public Issue announced by (erstwhile Binani Zinc Limited) in the Year 1994. Company has replied vide letter dated 23/06/2017 Action Taken Report sent on 12/06/2017 Clarification sought by SEBI on 14/06/2017 requesting them to close the complaint as there has been no response from the investor SEBI as on 01/08/2017 has requested us to send a detailed letter to the complainant and send us the copy of the POD. We have send a final letter to the shareholder and informed SEBI on 07/08/2017. However SEBI is yet to clear the complaint.

However since they still insists tha t the same has not been received b y them, we have requested them to send us the details of their bank ac counts from where the application money has been been paid and also a statement of the same bank acco unt for the period 23rd April 1994 to 22nd July 1994 (validity period of the refund order) as evidence th at the refund orders have not been credited to their account. A copy o f the said letters to Federal Bank a nd to the Investor is attached here with for your ready reference.

Even after providing the complain ant with the details of refund order s as per the paid list of Federal Ban k, the complainant insisted that he was not in receipt of the refund ord ers. As instructed by SEBI, we had written to the Bank to provide us d etails of the bank where the refund Binani orders have been credited and we h Industries Ltd ERO (1756) ad also written to the investors to g (COMB00168) ive us the proof that refund orders have not been encashed by them. We have not received any reply eit her from the Bank or from the Inve stor. Since there has been no respo nse from the investor, we request y ou to close the complaint.
