I, **CS** Mohammed Aabid of M/s Aabid & Co., Practising Company Secretaries, had been appointed as the Scrutinizer by the Board of Directors of **BINANI INDUSTRIES LIMITED** vide resolution dated 11th May, 2015 pursuant to Section 108 & Section 110 of the Companies Act, 2013 ("the Act") read with Rule 20 & 22 of the Companies (Management and Administration) Rules, 2014 ("the Rules"), to conduct the electronic voting process and to scrutinize the postal ballot forms received from the shareholders in respect of Special Resolution mentioned in the Postal Ballot Notice dated 11th May, 2015.

The Postal Ballot Notice along with explanatory statement setting out material facts therein, in respect of Special Resolution proposed to be passed by the Shareholders of the Company through postal ballot and through e-voting process were sent to the Shareholders on 22nd May, 2015.

The voting period for e-voting commenced from 10.00 a.m on 23rd May, 2015 (Saturday) and ended at 5.00 p.m on 22nd June, 2015 (Monday) and the CDSL e-voting platform was blocked thereafter. The votes cast under e-voting facility were then unblocked in the presence of two witnesses, who were not in the employment of the Company. Votes cast through postal ballot received up to 22nd June, 2015 were considered.

I have scrutinized and reviewed the voting tendered through electronic means based on the data downloaded from CDSL's e-voting system and the postal ballot forms received physically.
