I. - 2. 4. E-Voting:

The Company has engaged the services of CDSL to provide e-Voting facility to the Members to exercise their right to vote by electronic means to transact the business detailed in the Notice. I got myself registered with CDSL as the scrutinizer and downloaded the voting details using my login details.

- a) The Public Shareholders of the Company holding shares on the "cut-off" date i.e. 9th October, 2015, were entitled to vote on the Resolution as set out in the Notice of Postal Ballot and e-Voting.
- b) The e-Voting commenced on Friday, the 23rd October 2015 at 9.00 a.m. and ended on Sunday, the 22rd November 2015 at 5.00 p.m. and thereafter, the e-voting platform was disabled by CDSL.
- c) Thereafter, I unblocked the votes cast under e-voting facility in the presence of two witnesses, Pradip Bhattacharyaa and Sushil Tiwari, who are not in the employment of the Company.
